Category 1 - FULL MEMBERSHIP

OR
3. Horticulturists involved in education of landscape and consultation of landscape and carry the appropriate insurances.

The Board (minimum of 7) must not include more than 1/3 representation from the associate membership.

Category 2 - ASSOCIATE MEMBERSHIP

1. All corporate members not involved in contracting the installation of landscape.
2. All student members -
 - ◆ Not involved in contracting the installation of landscape. and
 - ◆ Not covered by the appropriate insurances and builders licence.
3. All lawn mowing enterprises -
 - ◆ Not involved in contracting the installation of landscape. and
 - ◆ Not covered by the appropriate insurances and builders licence.

Category 3 - ASSOCIATE GARDEN DESIGN MEMBERSHIP

Membership category for all **past** Garden Design students. Suitable for a two (2) year period after completion of a recognised garden design course. Non voting.

Category 4 – STUDENT MEMBERSHIP

Membership category for all students. Non voting.
